**ORDER IN CONNECTION WITH COURT'S ORDER ENTERED ON MAY 3, 2022
SUPPLEMENTING CONFIRMATION ORDER**

This matter coming before the Court in connection with the Order entered on May 3, 2022 Supplementing Confirmation Order (Docket 143), the Court having reviewed the applicable pleadings and being fully advised in the premises, and for the reasons stated on the record at the hearing on October 11, 2024,

THE COURT HEREBY FINDS AND ORDERS AS FOLLOWS:

(1) On March 18, 2022, U.S. Bank Trust National Association, as Trustee of the Lodge Series III Trust, and/or its assigns (the "Movant") filed an Amended Motion to Dismiss Case and for Order Barring Debtor from Refiling for 1 Year (Docket 121).

(2) The Order Supplementing Confirmation Order, entered on May 3, 2022, provides, in relevant part, that: (A) if the Movant does not receive any required payment by the due date, the Movant may issue a Notice of Default stating the amount of the default and giving the Debtor fourteen (14) days to cure the default; (B) the Notice of Default must be filed with the Court with a certificate of service on the Debtor and the Debtor's lawyer; (C) if the Debtor does not cure the default within fourteen (14) days after the date of receipt of the Notice of Default, the Movant may file an Affidavit of Default with a certificate of service on the Debtor and the Debtor's attorney; and (D) upon the filing of the Affidavit of Default and submission of an order to the Court, and without need for further hearing, the Debtor's chapter 13 case will be dismissed, and the Debtor will be barred from refiling any bankruptcy case for one year from the date of the entry of the dismissal order.

(3) The Debtor defaulted on the terms of the Order Supplementing Confirmation Order.

(4) The Movant filed a Notice of Default on August 16, 2024 (Doc. 156).


(5) The Debtor failed to cure the default within fourteen (14) days after the date of receipt of the Notice of Default.

(6) The Movant filed an Affidavit of Default and order on September 13, 2024 (Docket 157).

(7) On October 11, 2024, the Court entered an order denying the Debtor's motion to vacate the Order Supplementing Confirmation Order.

(8) The Debtor's chapter 13 case is dismissed, and the Debtor is barred from refiling any bankruptcy case for one year from the date of the entry of this order.
