AMENDED ORDER OF DISMISSAL WITH TWO-YEAR BAR RUNNING CONSECUTIVELY WITH PENDING BAR ORDER

(Correcting the Hearing on the Motion to September 1, 2022)

THIS MATTER coming before the Court on the Motion to Dismiss and to Bar Debtor from Refiling (ECF no. 18) brought Lydia S. Meyer, the Chapter 13 Trustee; the Motion being duly noticed and the Debtor having appeared before the Court for the presentment of the motion at which time she was afforded additional time to respond to the Motion and the matter was accordingly continued to September 1, 2022; the allegations of the Chapter 13 Trustee standing uncontroverted and the Court having considered the submissions of the parties and taking judicial notice of its docket, and otherwise being advised in the premises;

For the reasons set forth at the September 1, 2022, hearing on the Motion

THE COURT FINDS:

1. The Chapter 13 Trustee demonstrated that on July 28, 2022, the Debtor Andeiyi Griffith filed her Chapter 13 petition to commence this case;

2. The Debtor filed ten bankruptcy cases in four separate states over the past eight years, inclusive of the pending case;

3. The last such case, 21 BK 16733, was filed in the United States Bankruptcy Court for the District of Maryland on October 25, 2021;

4. On December 15, 2021, the bankruptcy court in Maryland granted the motion of the United States Trustee to dismiss that case for abuse, and dismissed the 2021 case with prejudice and with a one-year bar to the Debtor refiling a bankruptcy petition;

5. The Debtor filed her chapter 13 petition in this court in violation of the December 15, 2021 bar order; and

6. In this case, the Debtor filed only a skeletal petition; she has failed to propose a Chapter 13 plan and has not filed required schedules and credit counseling certificate.

IT IS HEREBY ORDERED that:

- 1. The Motion is GRANTED;
- 2. The relief granted herein shall not diminish the terms and effect of the order entered by the Bankruptcy Court for the District of Maryland, but shall in addition to the December 15, 2021 Order; and
- 3. This case is hereby DISMISSED, and the DEBTOR IS BARRED from directly or indirectly filing a bankruptcy petition or otherwise seeking relief under title 11 of the U.S. Code for a period of TWO YEARS, from December 15, 2021, until December 16, 2024, SUCH BAR TO RUN CONSECUTIVELY to the standing bar order issued by the Bankruptcy Court for the District of Maryland in its case number 21-16733.
