Order of Dismissal With Prejudice

This matter coming before the Court on the Fairbanks Capital's Motion to Dismiss this case, the Court finds that debtor is ineligible to have filed this case and that this case was furthermore filed in violation of a previous bar Order from case 03 B 35292. Based upon Dorothy Williams' abuse of the Bankruptcy Code,

IT IS HEREBY ORDERED:

1. Fairbanks Capital's motion to dismiss this case is granted.
2. Dorothy Williams, or anyone acting on her behalf, is enjoined pursuant to 11 USC §105 from filing any new bankruptcy petition under any chapter of the Bankruptcy Code in the United States Bankruptcy Court for the Northern District of Illinois without first obtaining leave and on notice to the Chapter 13 Standing Trustee Marilyn O Marshall (224 South Michigan, Suite 800, Chicago, IL 06064) and attorneys for Fairbanks Capital (Fisher & Fisher 120 N LaSalle, #2520, Chicago, IL 60602).
3. Any bankruptcy petition filed by Dorothy Williams, or anyone on her behalf, without first seeking and obtaining leave to file such a petition shall be deemed null and void.
4. Dorothy Williams shall follow these procedures in order to obtain leave to file a bankruptcy petition:
 - a) Any petition Dorothy Williams, or anyone acting on her behalf, wishes to proffer for filing shall be delivered to Room 710, Office of the Bankruptcy Clerk at 219 South Dearborn Street, Chicago, Illinois. Only the Clerk or deputies specifically designated by the Clerk may accept such documents.
 - b) When Dorothy Williams, or anyone acting on her behalf, seeks to proffer a bankruptcy petition, it shall be accompanied by a motion captioned "Motion Seeking Leave to File Pursuant to Order of Judge Pamela S Hollis." This motion shall, in addition to requesting leave to file the petition, include a sworn statement certifying that the circumstances of Dorothy Williams have changed so as to justify the filing of a new bankruptcy case.

5. When Dorothy Williams, or anyone acting on her behalf, proffers a petition for filing, the Clerk or designated deputy, shall accept the papers, stamp them received, and forward them to the then acting Chief Bankruptcy Judge.
6. The Chief Bankruptcy Judge, or in his absence either his successor in office or the acting Chief Bankruptcy Judge, will examine any bankruptcy petition proffered by or on behalf of Dorothy Williams to determine whether or not it shall be filed.
7. If the Chief Bankruptcy Judge enters an order denying leave to file the bankruptcy petition, the Clerk shall retain the order and a copy of the materials in a miscellaneous file and cause a copy of the order to be mailed to Dorothy Williams.
8. If the Chief Bankruptcy Judge enters an order granting leave to file the bankruptcy petition, the Clerk will cause the petition to be stamped filed as of the date of the order, and shall cause the case to be assigned to the appropriate judge designated to hear bankruptcy matters in the Northern District of Illinois, Eastern Division. The Clerk shall also cause a copy of the order to be mailed to Dorothy Williams.
9. Dorothy Williams's failure to comply with this order may, within the discretion of the Court, result in her being held in contempt of court and punished accordingly.
10. The Clerk shall create and maintain a miscellaneous file with a general title "In the matter of Dorothy Williams." The miscellaneous file shall serve as the repository of this order, all documents proffered for filing by Dorothy Williams covered by the terms of this order for which authority to file is not granted, and any order or minute order entered pursuant to that order. The Clerk will also maintain a miscellaneous docket associated with the file. All orders retained in the file will be entered on that docket following standard docketing procedures. A brief entry shall be made on the docket indicating the receipt of any materials from Dorothy Williams.
