The following are before the court:

3. **WRIT OF MANDAMUS**, filed on March 10, 2021, by the pro se petitioner in appeal no. 21-1452.

IT IS ORDERED that the petitions are **DENIED** as frivolous.

IT IS FURTHER ORDERED that petitioner Darnel Powell Bey's privilege to litigate civil suits in forma pauperis is **REVOKED**. Powell Bey must prepay the full filing fees for complaints in the district courts of this circuit and appeals or petitions taken to this court.

IT IS FINALLY ORDERED that unless and until Powell Bey pays his outstanding filing fees (including those incurred for these three petitions), the clerks of all federal courts in this circuit are directed to return unfiled any papers submitted either directly or indirectly by him or on his behalf. *See In re City of Chicago*, 500 F.3d 582, 585-86 (7th Cir. 2007); *Support Sys. Int'l, Inc. v. Mack*, 45 F.3d 185, 186 (7th Cir. 1995) (per curiam). In accordance with our decision in *Mack*, exceptions to this filing bar are made for criminal cases and for applications for writs of habeas corpus. *See Mack*, 45 F.3d at 186-87. This order will be lifted immediately once Powell Bey makes full payment. *See City of Chicago*, 500 F.3d at 585-86. If Powell Bey, despite his best efforts, is unable to pay in full all outstanding sanctions and filing fees, no earlier than two years from the date of this order he is authorized to submit to this court a motion to modify or rescind this order. *See id.*; *Mack*, 45 F.3d at 186.
